1. SCOPE OF WORK

2. PEST INCLUDED

Cockroaches, bedbugs, ants, beetles, silverfish, ticks, mites, lizards, flies, mosquitoes, wasps, rats and mice

The Second Party shall employ effective pest control measures to minimize and control these pest populations within the premises specified in this contract.

3. PEST EXCLUDED

Invaders shall adequately suppress indoor populations of pests covered under this contract. Any other pest encountered will be considered as additional service to this agreement.

- Birds, bats, snakes and all other vertebrates other than commensal rodents.
- Termites, carpenter ants nesting within structures and other wood destroying organisms;
- Pests that primarily feed on outdoor vegetation
- Plants and animals within an agreed building.

The Second Party shall discuss and agree with the First Party on the necessary actions, costs, and methods for addressing any excluded pests not covered under this contract.
